Action and Discussion Items:

Policy, First Reading: Safe Congregation Policy for Children and Youth

Mary McMurray and Jessica Zimmer-Saltzman presented a policy that encompasses background checks for childcare providers and other protections for RE-age children, as well as codifying certain records retention practices. The policy will be read a second time and voted on in October.

Policy, Second Reading: Harassment and Violence

Motion: Moved by McMurray and seconded to approve Harassment and Violence Policy. **Motion carried.**

Policy, First Reading: Vehicle Usage and Reimbursement

The Board considered a set of policies relating to appropriate use of vehicles by Society staff and volunteers while on Society business. The policy will be read a second time and voted on in October.

Policy, Second Reading: Disability

Motion: Moved by Protzman and seconded to approve Disability Policy. **Motion carried.**
