November’s Social Justice Offerings Benefit the Free Lunch Program (FLP)

Preparation and serving of the UUS Free Lunch shift every second Friday changed half a year ago to catered food, assembled in a clamshell container and handed out at a side door of the building. We have persisted, and those who make it to 1105 S. Gilbert Ct. get fed good food. As reported in the past, UUS has not missed a second Friday since 1986.

The Free Lunch Program as a whole is surviving with the help of continuing groups of volunteer servers—and many who support the program financially to offer “an open door, a full plate, no questions asked” six days a week. You can do that this month!

From Your Minister

On this eve of a monumental election, many of us wait with fear and anxiety, wondering what events around the election and the outcome will mean for our lives and our loved ones' lives. We wait, knowing that whatever the outcome, our quest to build a world of more justice, which is rooted in our Unitarian Universalist faith, is long-haul work. We sit here

knowing that this is long-haul work and we are long-haul people. We are rooted in a religious movement that gives us the strength, courage, patience, faith, and love that we need in order to be here and keep striving to build the world of greater justice that we seek.

And yet, as we sit here in a liminal space—a space where we are in between what has been but not yet in what is coming—I find myself just wanting to know. Anxious, not only about possible outcomes, but anxious because I have to wait. In this waiting, things that would normally frustrate us, like a dropped dish or the dog pulling too hard on the leash, can spark an outburst. Things that are a little bit funny can make us laugh, perhaps until we cry. And so, in the midst of this we can find ourselves simply wanting an outcome, an answer. Even as our rational minds tell us that could likely take weeks, and even once we have an election outcome, we will still be in the midst of the pandemic and we will still have the long-haul work.

So what do we do with this?

This month, when our Soul Matters theme is Healing, we'll be reflecting on different ways of engaging in the spiritual work of sitting in liminal space, making space for and processing our feelings, building our spiritual and emotional resources, and getting ourselves resourced for long-haul work. We'll be engaging in somatic work—work designed to help our bodies and limbic systems process the stress, anxiety, anger, fear, and trauma we're experiencing. We'll be holding vigils, worship services, and meditating or praying in the ways that speak to each of us. Some of us will be registering voters, making calls or sending postcards, attending marches, or being peacekeepers (a box on page 3 has information on UUS events surrounding the election). We'll be developing our spiritual resources as we engage with justice work as a spiritual practice, a spiritual path, and a faith journey.

And we'll be doing this together. We are not alone, none of us. No matter what our life circumstances are, how the pandemic has made us isolate, or our political views. None of us is alone. This congregation is here to hold all of us, to proclaim our inherent worth and dignity, even as it invites all of us to greater and deeper personal development and justice work, to help us cultivate compassion and presence, and to help us do the things that seem impossible when we're alone.

And so I hope you'll join us for worship services, vigils, classes, or other events this month. And may each and every one of us find the strength, courage, patience, faith, and love to keep our hearts open, to live love and justice, and to continue to do our healing work, alone and together.

Simon, a UUS member and inmate at Iowa Medical and Classification Center, has served 34 years of a life sentence and is well known to several at UUS. Prior to COVID-19, Simon had UUS visitors, usually involving a Scrabble game, and a few who periodically helped with financial contributions for basic items.

Joe Brisben was the major financial supporter of Simon. In Joe’s absence and memory, the Prison Ministry Team is trying to continue this support by asking UUS members to contribute \$100 in a one-time gift or recurring monthly donations of \$10 via Realm (onrealm.org/uusic/give/PrisonMinistry) for one year. We are close to our goal and only need a few more UUS members to answer this appeal. Please help if you can. They are free to receive, to welcome, to accept.” That's hard work, but it's what we must do to become or remain connected in a world that is pulling us apart.

Treasurer's September Financial Report Excerpt

Overall, our bank accounts (cash available) remain stable. This is a credit to staff and committees effectively following the restricted spending guidelines the Board has instituted due to COVID. The end-of-month total for our various Operating Bank Accounts equals \$379,120. These include our several operating accounts and the remainder of the Capital Campaign funds. These accounts have been steady around the 350k-400k level all this year. (Income or Expenses can spike in any given month causing fluctuations within that 50k range.) This steadiness indicates no current concerns of overspending the 2020 budget.

Endowment Funds end-of-month totals equal \$1,402,000. These several stock funds' value generally follows the stock market values. We have been taking \$12,800 out per month for operating expenses beginning in May and ending in December. Despite taking these monies out, we are still on the positive side for the year.

The Finance and Endowment Committees continue to work on Policy and Procedures as the Board requested. The Stewardship Team has nicely launched the 2021 Pledge Campaign. Pledges are coming in and being tracked. The Endowment Committee has agreed to contribute 5% of the General Endowment to the 2021 Operating Budget as the Annual Spending Allowance (ASA). They look forward to receiving proposals for the use of Detiger and Reese funds for other appropriate necessary expenses.

After gaining approval from the Finance Committee and the Executive Committee, we have agreed to a proposal from Central State Bank to refinance our building mortgage on December 1st, 2020, with a balance owed of about \$840,000. We will have a loan of that amount at 3.55% interest on a five-year term, with \$500 in bank fees. These numbers are at the very low end of costs for the current market. We will amortize payments (\$5,000/month) over 20 years, instead of 15 years (\$6,000/month). We can, over the five years, make extra principle payments if we wish. We await the final contracts and a closing date.

Message on 2020 Budget Spending

Sent to group leaders and staff on October 25th

UUS Program Chairs and Staff,

Firstly, I want to thank all of you for following so nicely the restrictions on spending that the Executive Committee instituted when COVID-19 hit and we closed the building. Your restraint has allowed UUS to proceed with its essential functions and services to the community without harming our finances. Again, thank you.

In the early months of COVID, "Please don't spend" was the rule of the day for committees, teams, groups, and staff. In July the dictate was loosened. A catchphrase for where we are now is:

"If you judge that the health of the community or your program's work requires you to spend budgeted funds, do it. If not, please don't."

For donations of budgeted funds to justice organizations or efforts, please consider the question: **"Does this outside group need our help now, or can it wait?"**

These guidelines will be the rule of the day through the remainder of 2020. We will reassess spending guidelines for the 2021 budgets that will go into effect January 1st, 2021.

Congregational Administrator's September Financial Report Excerpt

September pledge payments are down again compared to last month (59% of budgeted monthly income was received in September compared to 74% in August). Year-to-date we are down from budget (59% of our pledge goal vs. an anticipated 75%). The deficit is due in part to a late September bank deposit that didn't hit the bank until October, but income is also clearly being affected by the anticipated decrease in pledge payments. Total Operating Income for August was \$23,359.27 (not including restricted giving).

In September, UUs raised \$1,177 for our various social justice agencies (including \$992 for Shelter House, \$135 extra for the Free Medical Clinic, and \$50 extra for the August 5th Sunday agency, the Eastern Iowa Community Bond Project). A Faithify campaign run by UUS and Peoples in Cedar Rapids raised \$3,481.72 for derecho relief in the Corridor. There was also \$120 in additional BLM sign sales, and \$400 for the RJT's Negro Artist online performance and book sales.

Expenses continue to mostly stay well below budget with staff and groups observing the non-essential spending freeze set in place by the Board.

Unitarian Universalist Society Board of Trustees Meeting Highlights

October 21st, 2020 (virtual via Zoom)

Board meeting minutes are available on the website or can be requested from the UUS administrator.

PRESENT: Joe Rasmussen (President), Alan Swanson (Vice-President), Amy Fretz (Past-President), Mike Pavelich (Treasurer), Carol Adamson (Secretary), John Raley (Financial Trustee), Colleen Higgins (Trustee), Paul Pomrehn (Trustee), Julia Audlehelm (Trustee), and Rev. Diana Smith (Minister, Ex-Officio). **GUESTS:** Deb Schoelerman

Board President Joe Rasmussen called the meeting to order at 7:05 pm.

CONSENT AGENDA: Consent agenda and other items are uploaded to Dropbox for Board review prior to the meeting.

The Board voted and received the consent agenda and approved the September Board Minutes, October Executive Committee minutes, Staff report, Treasurer report and financial summary, affiliation agreement for Rev. Lois Cole.

STAFF HIRING: Rev. Smith provided a summary of the work she has done so far to find a replacement for Aura Strohschein (Accompanist/Music Facilitator) whose last day at UUS will be September 20th, 2020. Rev. Smith will be hiring a new (permanent) Accompanist and a (temporary) Music Facilitator.

COMMITTEE UPDATES

Rasmussen reviewed the current membership of the Board Committees. Next month we will have a formal appointment of the non-elected Board Committee members. There was discussion about their term of appointment, serving as co-chair, and ex officio status of staff members. Pomrehn and Raley said each committee has its own needs and cycles, and they would like to determine terms, etc., in consultation with their committees.

UNFINISHED BUSINESS

- **UUS Shared Ministry: Board Policies and Procedures**—*The Board substituted the endowment sections with sections proposed by the Endowment Committee and voted to officially adopt with immediate effectiveness the UUS Shared Ministry—Board Policies and Procedures.*
- **Building Re-opening: Benchmarks and Phases**—Rev. Smith reported that the COVID team has determined safe practices for Halloween, Remembrance Service, and Treats and Talents, and for those working on the grounds. The team has also developed safe practices for in-person pastoral care at the building. The COVID team asked for approval to change the benchmark measurement to a 14-day rolling average and, if the 14 day rolling average is 1% above the current phase for more than 7 days or if there is a bad outbreak, the UUS may go back to the previous phase. *The Board voted and approved these changes to the benchmark criteria.*
- **Mortgage Refinance**—Pavelich provided an update on the status of the mortgage refinance. The Finance and Executive Committee have already unanimously approved the agreement, and the Finance Committee is awaiting the final contract and a closing date. *The Board voted and approved the CSB agreement for an \$840,000 loan refinance with 3.55% interest on a 5-year term, with \$500 in Bank fees, and amortize payments (\$5,000.00/month) over 20 years.*

NEW BUSINESS

- **Memorial Garden Proposal**—Audlehelm described the Land Ministry's plans for the UUS Memorial Garden. Since the original site plan had the garden placed in an inaccessible location, the site has been changed to an accessible spot closer to the back of the building and visible from the sanctuary.
- **Purchase of Audio-visual Equipment for Live-streaming**—Rasmussen reported that AV equipment is now more readily available but there is a 4-6 week lead time for the installation. Raley said the Endowment Committee will need to approve the funding source and will need to ensure that the purchase will involve outreach to the greater community. *The Board voted and approved the purchase of the AV equipment regardless of the funding source.*
- **Budget line items for Board of Trustees**—*The Board voted to approve adjustments in its line items for 2021 and forwarded those to the Finance Committee.*
- **Follow-up Meeting with UUA Consultant & Board-Minister Covenant**—There was consensus that an initial meeting with Rev. Sharon Dittmar (UUS's new UUA MidAmerica Region contact person for Congregational Life) would be held on the morning of Saturday, November 21st, 2020, to acquaint Rev. Dittmar with UUS and develop the Minister Covenant.
- **January Planning Meeting**—Rasmussen suggested we have a Planning meeting in January 2021 and a Board Retreat in June 2021. The Retreat would include both old and new Board members. After discussion, there was consensus to schedule these events as Rasmussen suggested.
- **Group Read: Congregational Leadership in Anxious Times by Peter Steinke**—Rev. Smith recommended this book for a group read as we are in anxious times. The book gives us a common language and tools to explore and understand how to best lead through these difficult times. The group discussed part one: "The Leader's Presence." At the November meeting we will discuss part two: "The Leader's Functioning."

Rasmussen adjourned the meeting at 9:42 pm. The next meeting is Wednesday, November 18th, at 7 pm.
